ADVERTISEMENT FOR BIDS

Sealed Bids for the construction of the **Eaglehurst Drive Water Main & Sanitary Sewer Extension, Project No. 18258** will be received, by **the Charter Township of Garfield**, at the Township Offices located at **3848 Veterans Drive, Traverse City, MI 49684**, until **11 A.M.** local time on **April 25, 2019** at which time the Bids received will be publicly opened and read.

This project includes:

- Extension of approximately 850 linear feet of 8-inch SDR 35 sanitary sewer by method of open cut. All sanitary sewer shall be installed with public ROW and/or easements and include manholes and service leads.
- Extension of approximately 1,250 linear feet of 8-inch C900 water main by method of open cut. All water main shall be installed within public ROW and/or easements and include valves, hydrants, and service leads.

Bids will be received for a single prime Contract. Bids shall be on a lump sum and unit price basis, with additive alternate bid items as indicated in the Bid Form.

Printed copies of the Bidding Documents may be obtained from the Issuing Office, during the hours indicated above, upon receipt of a non-refundable payment of **\$50** for each set. Checks for Bidding Documents shall be payable to "**Gourdie Fraser, Inc.**". Upon request and receipt of the payment indicated above plus a non-refundable shipping charge **if the bidder has requested "Overnight" shipping**, the Issuing Office will transmit the Bidding Documents via delivery service. Partial sets of Bidding Documents will not be available from the Issuing Office. Neither Owner nor Engineer will be responsible for full or partial sets of Bidding Documents, including Addenda if any, obtained from sources other than the Issuing Office.

Alternatively, Bidding Documents are also available on compact disc or through a File Sharing site (as portable document format (PDF) files) for a non-refundable charge of **\$25**, including shipping via overnight express service.

Each Bidder must deposit with their Bid, security in the amount and form as specified by the conditions provided in the Information for Bidders. Bids not accompanied by a proper Bid bond or certified check in the amount stated in the documents, or received after the above date and time will not be considered. Fax transmittals of Bids or Bid bonds will not be accepted.

The Owner reserves the right to waive any informalities or to reject any or all Bids.
No Bidder may withdraw their Bid within 90 days after the actual date of Bid opening.
