- Approximately 25,200 lineal feet of 8" sanitary sewer by method of open cut, bore and jack and & directional drill
- Approximately 7,300 linear feet of 1½" through 6" sanitary force main by method of open cut, bore and jack and directional drill
- Manholes, cleanouts, and associated appurtenances
- New sanitary service leads
- Three (3) sanitary pump stations
  - One (1) 30 Hp non-clog submersible pump station equipped with Variable Frequency Drives, pumps, control panel, electrical and associated appurtenances.
  - One (1) 10 Hp submersible grinder station equipped with Variable Frequency Drives, pumps, control panel, electrical and associated appurtenances
  - One (1) 3 Hp submersible grinder station equipped with Variable Frequency Drives, pumps, control panel, electrical and associated appurtenances
