Construction of a Wastewater Treatment Facility - The Work under this contract consists of the following listed items and includes, but is not limited to, the furnishing of all labor, materials, tools and equipment, to properly install, construct or complete as indicated on the drawings and specifications.

Headworks Building

1. Building plumbing, electrical, heating, cooling, ventilation and lighting.
2. Flooring, ceiling, walls and laboratory furniture.
3. Process treatment electrical wiring, telemetry connections and conduit.
4. Mechanical fine screen.
5. Influent parshall flume and appurtenances.
6. Chemical feed system.
7. All other miscellaneous building mechanical piping, fittings and valves.

Wastewater Treatment Facility

1. Supply, unload, storage, installation and testing of the “Wastewater Treatment Equipment Package” as manufactured by Aero-Mod, Inc. Refer to Information Available to Bidders “Aero-Mod Scope of Supply – Tuscarora Township Wastewater Treatment Facility”
2. All other miscellaneous building mechanical piping, fittings and valves.
3. Sludge storage tank decant valves and pumping appurtenances.
4. Aluminum hand railing and stairs.
