

**CHARTER TOWNSHIP OF GARFIELD
N WEST SILVER LAKE ROAD SANITARY SEWER EXTENSION**

ADVERTISEMENT FOR BIDS

Sealed Bids for the construction of the **N West Silver Lake Road Sanitary Sewer Extension, Project No. 22230** will be received, by the **Charter Township of Garfield**, at the Township Offices located at **3848 Veterans Drive, Traverse City, MI 49684**, until **4:00 PM** local time on Wednesday **February 13, 2024**, at which time the Bids received will be publicly opened and read.

Sanitary Sewer extension from the existing Garfield system, along N West Silver Lake Road, from Green Meadow Drive, northeast to, Francisco's Market (intersection of N West Silver Lake Rd and Zimmerman Rd). Scope of work includes the following:

- A. Installation of approximately 950 linear feet of 8" C900 PVC sanitary sewer by method of open cut.
- B. Installation of approximately 350 linear feet of 8" HDPE sanitary sewer by method of directional drill.
- C. All sanitary sewer shall be installed within the public right-of-way and/or easements and including manholes, and restoration.
- D. Connection of new sanitary sewer to existing sanitary sewer system at MH#1013.

Alternate:

- A. Installation of approximately 350 linear feet of 8" C900 PVC sanitary sewer by method of open cut.
- B. Installation of approximately 950 linear feet of 8" HDPE sanitary sewer by method of directional drill.
- C. All sanitary sewer shall be installed within the public right-of-way and/or easements and including manholes, and restoration.
- D. Connection of new sanitary sewer to existing sanitary sewer system at MH#1013.

Bids will be received for a single prime Contract. Bids shall be on a unit price basis.

Upon request and receipt of the payment indicated above plus a non-refundable shipping charge **if the bidder has requested "Overnight" shipping**, the Issuing Office will transmit the Bidding Documents via delivery service. Partial sets of Bidding Documents will not be available from the Issuing Office. Neither Owner nor Engineer will be responsible for full or partial sets of Bidding Documents, including Addenda if any, obtained from sources other than the Issuing Office.

Alternatively, Bidding Documents are also available on compact disc or through a File Sharing site (as portable document format (PDF) files) for a non-refundable charge of **\$25**, including shipping via overnight express service.

Each Bidder must deposit with their Bid, security in the amount and form as specified by the conditions provided in the Information for Bidders. Bids not accompanied by a proper Bid bond or certified check in the amount stated in the documents, or received after the above date and time will not be considered. Fax transmittals of Bids or Bid bonds will not be accepted.

The Owner reserves the right to waive any informalities or to reject any or all Bids.

No Bidder may withdraw their Bid within 90 days after the actual date of Bid opening.
