The Addendum is issued prior to the receipt of bid proposals to amend the Contract Documents as follows. Bidders shall acknowledge receipt of this addendum by means of acknowledging on Page 1 of the Bid Form (EJCDC C-410).

CLARIFICATIONS:

Contractor shall provide all equipment and materials as necessary to complete the work outlined in the proposal. The following clarification is noted below.

Schedule

The Contractor is responsible for completing the project within the timelines noted in EJCDC C520 Contract provided in the bid documents. However, it is understood that final completion is subject to material availability. If manufacturing and/or delivery of supplies delays are encountered, the Township is willing to provide a reasonable time extension to accommodate as negotiated with the contractor after award of the project. All work to be completed to prepare for materials and supplies shall be performed timely consistent with the terms of the Contract.

Prefabricated Bathroom:

• In an effort to expedite supply and delivery, the Township is pre-purchasing the proposed bathroom facility including transportation and delivery to the site. The contractor is responsible for the coordination with the Township and Engineer. The Contractor is also responsible for the offloading upon site delivery, storage, protection, mobilization, and installation according to the manufacturer recommendation. The Specification 13340 and Detail sheet 4.3 included in the bid package are for reference.

DRAWINGS

- Sheet 3.1 and 4.1 Clarification to Bollards: The existing bollards are treated wood posts and to be salvaged and relocated, embedded in concrete encasement. The detail on Sheet 4.1 for bollards illustrates concrete filled steel posts which are not applicable and shall be stricken from the detail sheet.
- Sheets 3.1 Clarification to Water Service Lead: The proposed water service shall be 2" HDPE DR 9 and extend and connect into the existing pole barn. The contractor shall be responsible to coordinate work with Lautner Irrigation.

SPECIFICATIONS

• EJCD C-410 shall be stricken in its' entirety and replaced with the attached. The bid form has been updated to account for the bathroom clarification and adjustments to HMA and water service line quantities.

- B. Bidder has visited the Site, conducted a thorough, alert visual examination of the Site and adjacent areas, and become familiar with and satisfied itself as to the general, local, and Site conditions that may affect cost, progress, and performance of the Work.
- C. Bidder is familiar with and has satisfied itself as to all Laws and Regulations that may affect cost, progress, and performance of the Work.
- D. Bidder has considered the information known to Bidder itself; information commonly known to contractors doing business in the locality of the Site; information and observations obtained from visits to the Site; the Bidding Documents; and any Site-related reports and drawings identified in the Bidding Documents, with respect to the effect of such information, observations, and documents on (1) the cost, progress, and performance of the Work; (2) the means, methods, techniques, sequences, and procedures of construction to be employed by Bidder; and (3) Bidder's safety precautions and programs.
- E. Bidder agrees, based on the information and observations referred to in the preceding paragraph, that no further examinations, investigations, explorations, tests, studies, or data are necessary for the determination of this Bid for performance of the Work at the price bid and within the times required, and in accordance with the other terms and conditions of the Bidding Documents.

- F. Bidder is aware of the general nature of work to be performed by Owner and others at the Site that relates to the Work as indicated in the Bidding Documents.
