Sealed Bids for the construction of the **Sanitary Sewer Pump Station #1 Upgrades, GFA Project No. 18113** will be received, by **the Charter Township of Union**, at their office located at **5228 South Isabella Road, Mt Pleasant, MI 48858**, until **10:00 AM** local time on **March 23, 2022** at which time the Bids received will be publicly opened and read. Funding for this project is through Charter Township of Union and Economic Development Authority (EDA).

The Project consists of upgrades and relocating the existing Sanitary Sewer Lift Station No. 1 that is located on Township owned property on Enterprise Drive. The lift station will be relocated roughly 180 feet to the south of the existing station. Work will include bypass pumping, sheet piling and site restoration to facilitate installation of the infrastructure.

The following is proposed:

- Construction of a new 400 GPM submersible Sanitary Sewer Lift Station No. 1 to include a wet well, pumps/motors, mechanical piping and valves, valve/meter vault, control panel including variable frequency drives, access driveway and site electricity improvements.
- Abandonment of existing pump station #1 and appurtenances.
- 180 feet of 12 inch truss gravity sewer and associated appurtenances.
- 180 feet of 6 inch SDR 21 force main and associated appurtenances.

Bids will be received for a single prime Contract. Bids shall be on a lump sum and unit price basis, with additive alternate bid items as indicated in the Bid Form.
