ADVERTISEMENT FOR BIDS

Sealed Bids for the installation of a High Service Pump at River Rd Control Building, **GFA Project No. 21092** will be received, by **the Charter Township of Union**, at their office located at **5228 South Isabella Road, Mt Pleasant, MI 48858**, until **10:30 AM** local time on March 23, 2022 at which time the Bids received will be publicly opened and read. Funding for this project is through Charter Township of Union.

The Project consists of the installation of a high service pump in the existing River Rd Control Building. The contractor is responsible for all associated mechanical and electrical installation.

A. MECHANICAL IMPROVEMENTS AT CONTROL BUILDING:

- Installation of one (1) vertical split case high service pump with a capacity of 850 gpm.*
- Installation of piping, valves, fittings and associated appurtenances.
- Installation of a stand-by generator and automatic transfer switch (ATS) at the control building.

B. INSTRUMENTATION / ELECTRICAL IMPROVEMENTS:

- Installation of new variable frequency drive and associated appurtenances and SCADA/programming.
- Coordinate the conversion of incoming power from 1 phase 240V, to 3 phase 480V service, including associated internal service and wiring upgrades.

*An alternate pump skid package including pump, piping and accessories is available for this project.

Bids will be received for a single prime Contract. Bids shall be on a lump sum and unit price basis, with additive alternate bid items as indicated in the Bid Form.

Upon request and receipt of the payment indicated above plus a non-refundable shipping charge **if the bidder has requested "Overnight" shipping**, the Issuing Office will transmit the Bidding Documents via delivery service. Partial sets of Bidding Documents will not be available from the Issuing Office. Neither Owner nor Engineer will be responsible for full or partial sets of Bidding Documents, including Addenda if any, obtained from sources other than the Issuing Office.

Alternatively, Bidding Documents are also available on compact disc or through a File Sharing site (as portable document format (PDF) files) for a non-refundable charge of **\$25**, including shipping via overnight express service.

Each Bidder must deposit with their Bid, security in the amount and form as specified by the conditions provided in the Information for Bidders. Bids not accompanied by a proper Bid bond or certified check in the amount stated in the documents, or received after the above date and time will not be considered. Fax transmittals of Bids or Bid bonds will not be accepted.

The Owner reserves the right to waive any informalities or to reject any or all Bids.

No Bidder may withdraw their Bid within 90 days after the actual date of Bid opening.
